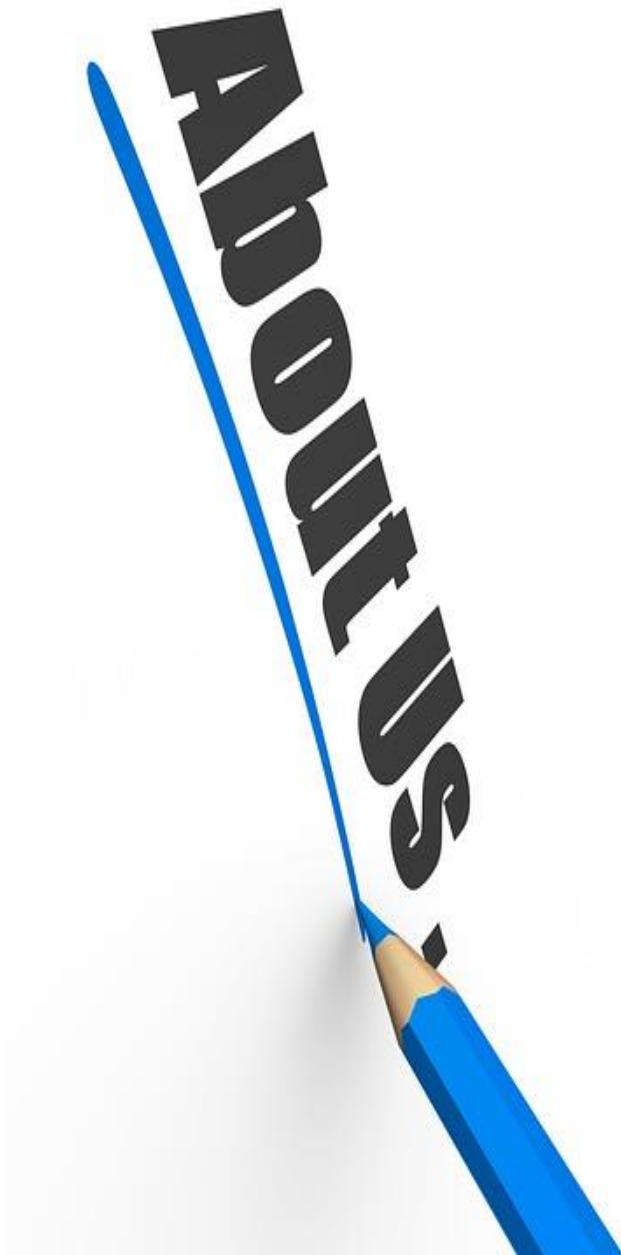

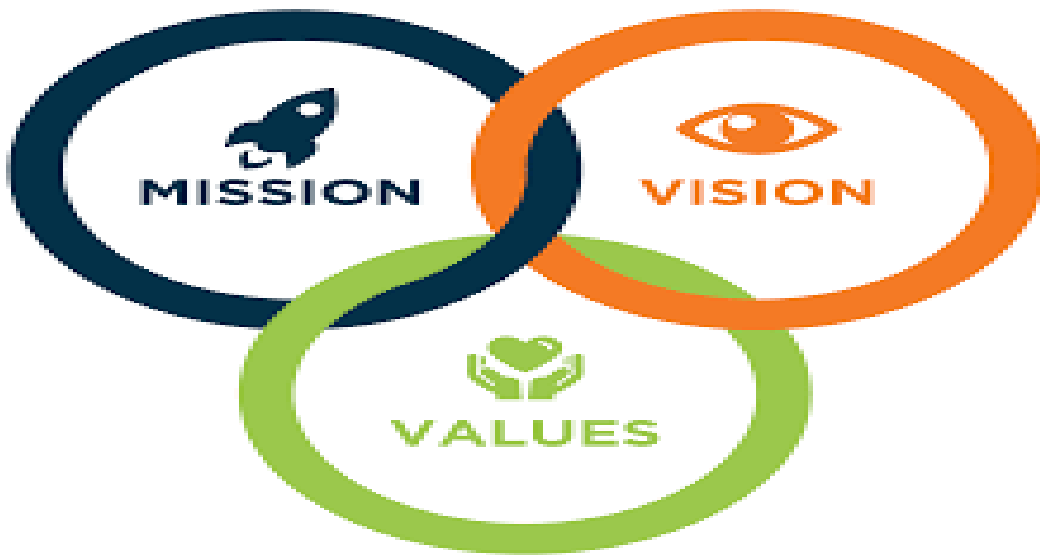
The Firm has represented hundreds of clients before arbitration tribunals in local and international disputes and before Egyptian courts of different degrees.

Incorporation

Over and above the incorporation of business companies, whether partnerships or corporations, our services extend to offering the necessary advice to clients, assisting them to choose the type of the company that fits their activity the best.

The types of companies provided for under Egyptian law include:

- Joint stock companies
- Partnership Limited by Shares companies
- Limited Liability Companies
- Limited partnerships
- Joint Liability companies

The Firm also drafts and prepares legal agreements that usually precede the incorporation of companies and regulate the relationship between partners ahead of the incorporation of the company. Such agreements can typically include a Memorandum of Understanding (MOU), management contracts, Letters of Intent (LOI), in addition to the preparation of Articles of Incorporation, agreements, and many similar contracts.

The Firm also helps foreign companies to open branches in Egypt and to obtain the necessary licenses.

(Drafting and ratifying OGM / EGM / BOD Minutes)

The Firm offers services that assist boards to ensure legal compliance by drafting Ordinary and Extraordinary General Meetings' Minutes, as well as Board of Directors' Minutes also If necessary, it participates in attending such meetings to ensure the meeting's quorum - and other requirements stated in the law – are met.

The Firm also ratifies such meetings at the GAFI after completing all documents needed for approval, and in accordance with the laws and the governance rules applicable in Egypt.





Drawing up of Contracts:

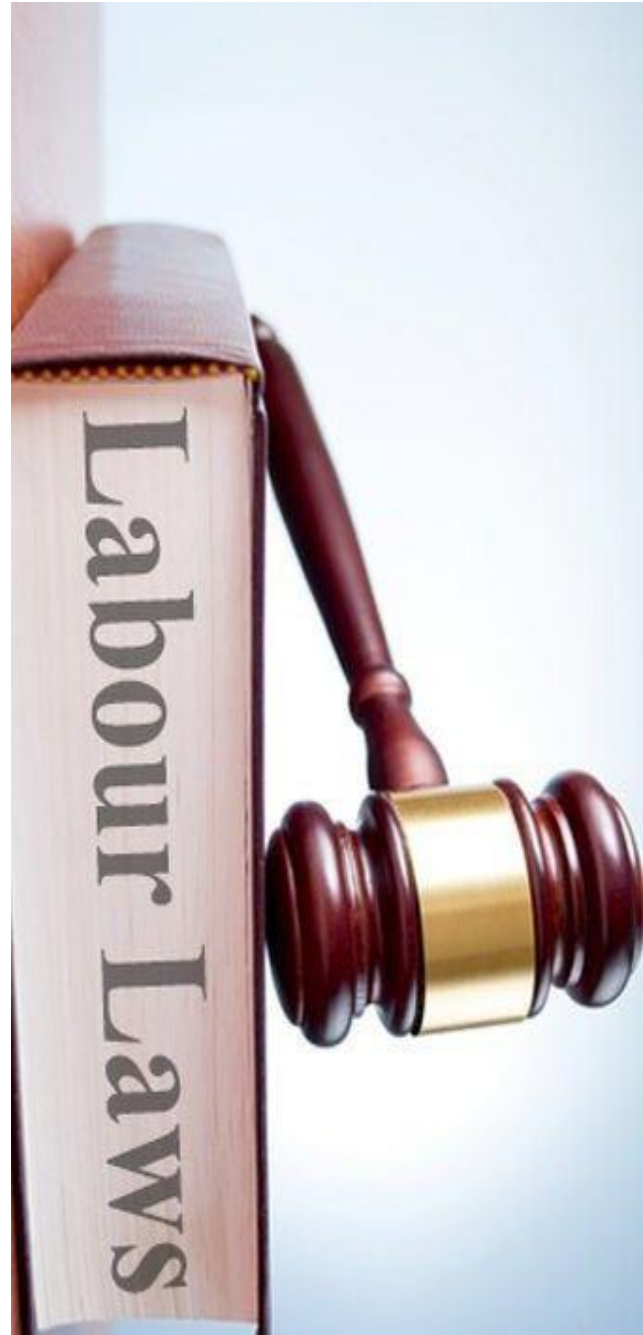

Banking & Financial

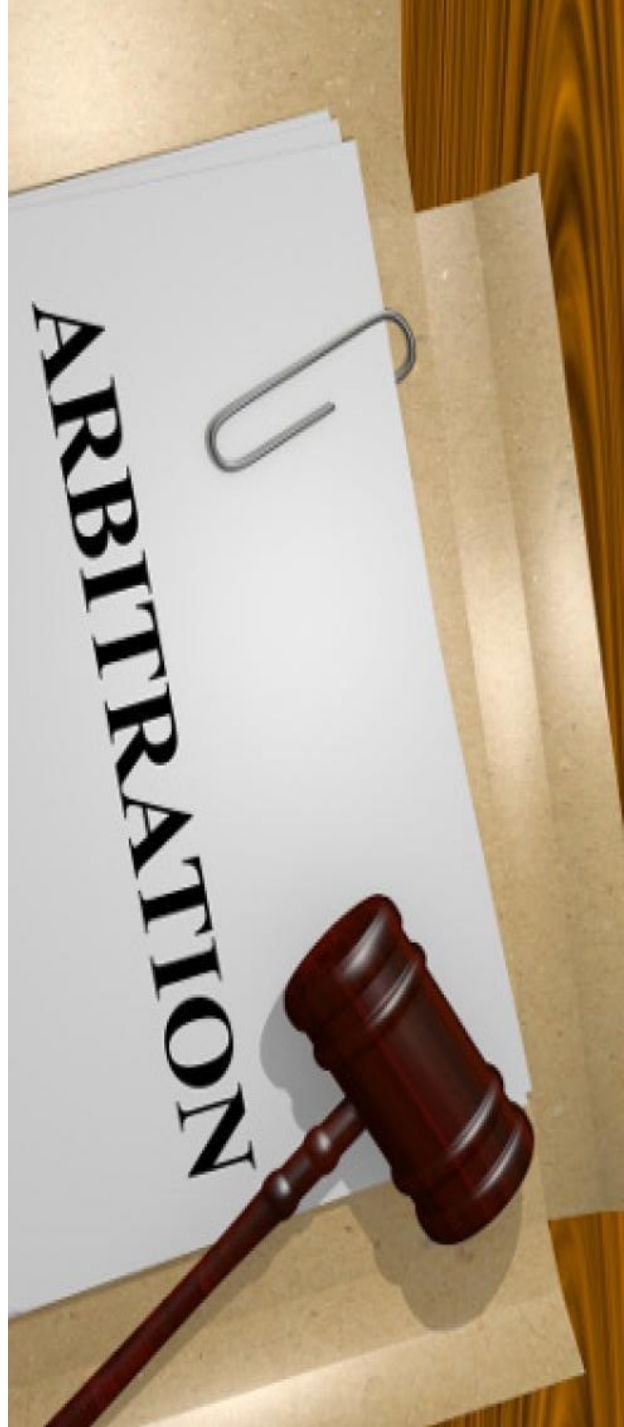

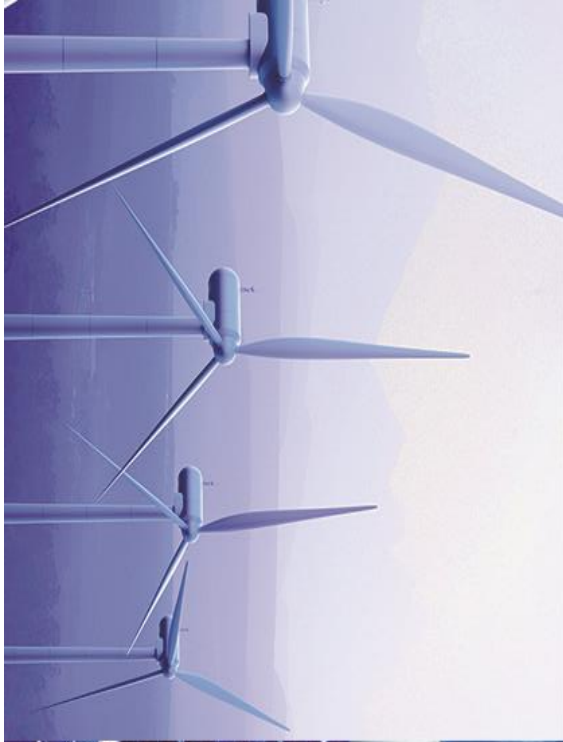
The Firm has been successful in collecting many commercial debts from individuals or corporations through negotiations.
